



## PERIODIC DISCLOSURE ON THE PURCHASE OF OWN SHARES 11 AUGUST 2025 – 15 AUGUST 2025

OVS S.p.A. ("OVS" - OVS.MI) informs to have purchased on *Euronext Milan*, in the period between 11 August 2025 and 15 August 2025, no. 87,239 ordinary shares (equal to 0.034% of the share capital) at the average unit price of Euro 3.7059 for a total amount equal to Euro 323,301.66.

Such transactions were carried out as part of the authorization to the purchase of own shares approved by the Shareholders' Meeting of 30 May 2025, implementing the purchase program launched on 9 June 2025 (already object of disclosure also pursuant to art.144 bis of the CONSOB Regulation 11971/99 and to art. 132 of D.Lgs. n. 58/98).
