Please note that this perimeter includes all assets, legal relationships, and resources functionally organized for the conduct of the B2B business unit of GO Internet, including the B2B business unit and GO Internet’s equity interest in X-Stream S.r.l., as well as the equity interest held by Tiscali Italia in Aetherna S.r.l., subject to the exclusions, limitations, and clarifications set forth in the Offer and the related contractual and procedural documentation.

It should be noted that the completion of the transaction remains subject to the fulfillment of the applicable conditions precedent, the issuance of the authorizations and approvals required pursuant to Article 22, paragraph 1, subparagraph d), CCII, the absence of objection by the expert appointed in the context of the negotiated settlement, the finalization and signing of the relevant contractual documentation, the obtaining of any authorizations and/or clearances required under antitrust and golden power regulations, as well as the fulfillment of the additional obligations provided for in the Offer and applicable law.
