Milan, 17 December 2025 – WIIT S.p.A. (“WIIT” or the “Company”; ISIN IT0005440893; WIIT.MI), one of the leading European players in the market of Cloud Computing services for enterprises focused on the provision of continuous *Private and Hybrid Cloud* services for critical applications, announces the signing of a **new 5-year contract** for *Private Cloud* and *Disaster Recovery* services with a major group (the “Customer”), **for a total value of over €2.1 million**.

This configuration also helps mitigate geopolitical risk, ensuring uncompromising protection and total operational continuity. These are fundamental elements for managing critical processes, where rapid response times, protection of sensitive information, and the ability to support complex operational flows are key factors for success.
