(“TIP” – MI) independent and diversified investment / merchant bank listed on the STAR segment of Borsa Italiana (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Stock Exchange Market, according to the Shareholders’ Meeting on April 29, 2020 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 62,267 TIP S.p.A. ordinary shares (equal to 0.034% of share capital) throughout December 21, 2020, to December 25, 2020, at a weighted average price of 6.7936 Euro, at the countervalue of 423,018.17 Euro.
