(LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Stock Exchange Market, according to the Shareholders’ Meeting on April 29, 2021 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 129,723 TIP S.p.A. ordinary shares (equal to 0.070% of share capital) throughout July 19, 2021, to July 23, 2021, at a weighted average price of 7.9804 Euro, at the countervalue of 1,035,238.02 Euro.
