(LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Stock Exchange Market, according to the Shareholders’ Meeting on April 29, 2021 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 82,158 TIP S.p.A. ordinary shares (equal to 0.045% of share capital) throughout September 13, 2021, to September 17, 2021, at a weighted average price of 9.0622 Euro, at the countervalue of 744,532.89 Euro.
