(codice LEI 81560017CF8066680595) comunica di aver acquistato sul Mercato Telematico Azionario, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 29 aprile 2021 (già oggetto di informativa anche ai sensi dell’art.144 bis del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 27 settembre 2021 all’1 ottobre 2021 n. 107.692 azioni ordinarie (pari allo 0,058% del capitale sociale) al prezzo medio ponderato di euro 9,1207 per un controvalore complessivo di euro 982.225,75.

Tamburi Investment Partners S.p.A. (“TIP” – MI) independent and diversified industrial group listed on the STAR segment of Borsa Italiana S.p.A. (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Stock Exchange Market, according to the Shareholders’ Meeting on April 29, 2021 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 107,692 TIP S.p.A. ordinary shares (equal to 0.058% of share capital) throughout September 27, 2021, to October 1, 2021, at a weighted average price of 9.1207 Euro, at the countervalue of 982,225.75 Euro.

Purchases were made through the intermediary Equita Sim S.p.A. (code LEI 815600E3E9BFBC8FAA85).
