(“TIP” – tip.mi) independent and diversified industrial group listed on the Euronext STAR Milan (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 29, 2021 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 83,084 TIP S.p.A. ordinary shares (equal to 0.045% of share capital) throughout January 10, 2022, to January 14, 2022, at a weighted average price of 9.5503 Euro, at the countervalue of 793,479.71 Euro.
