(“TIP” – tip.mi) gruppo industriale indipendente e diversificato quotato al segmento Euronext STAR Milan (codice LEI 81560017CF8066680595) comunica di aver acquistato sul mercato Euronext Milan, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 28 aprile 2022 (già oggetto di informativa anche ai sensi dell’art.144 bis del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 4 luglio 2022 all’8 luglio 2022 n. 37.870 azioni ordinarie (pari allo 0,021% del capitale sociale) al prezzo medio ponderato di euro 7,3010 per un controvalore complessivo di euro 276.489,47.

DISCLOSURE REGARDING THE PLAN FOR THE PURCHASE OF TREASURY SHARES

Tamburi Investment Partners S.p.A. (“TIP” – tip.mi) independent and diversified industrial group listed on the Euronext STAR Milan (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 28, 2022 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 37,870 TIP S.p.A. ordinary shares (equal to 0.021% of share capital) throughout July 4, 2022, to July 8, 2022, at a weighted average price of 7.3010 Euro, at the countervalue of 276,489.47 Euro.

Purchases were made through the intermediary Equita Sim S.p.A. (code LEI 815600E3E9BFBC8FAA85).
