## DISCLOSURE REGARDING THE PLAN FOR THE PURCHASE OF TREASURY SHARES

(“TIP” – tip.mi) independent and diversified industrial group listed on the Euronext STAR Milan (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 28, 2022 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 20,133 TIP S.p.A. ordinary shares (equal to 0.011% of share capital) throughout December 27, 2022, to December 30, 2022, at a weighted average price of 7.2553 Euro, at the countervalue of 146,070.28 Euro.
