("TIP" – tip.mi) independent and diversified industrial group specialized in active investment in excellent companies, listed on the Euronext STAR Milan (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders' Meeting on April 27, 2023 approval, (already announced in according to article 132 of "Testo Unico della Finanza" and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 41,989 TIP S.p.A. ordinary shares (equal to 0.023% of share capital) throughout May 15, 2023, to May 19, 2023, at a weighted average price of 8.7317 Euro, at the countervalue of 366,636.19 Euro.
