(“TIP” – tip.mi) gruppo industriale indipendente e diversificato specializzato nell’investimento attivo in imprese eccellenti, quotato al segmento Euronext STAR Milan (codice LEI 81560017CF8066680595) comunica di aver acquistato sul mercato Euronext Milan, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 27 aprile 2023 (già oggetto di informativa anche ai sensi dell’art.144 bis del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 17 luglio 2023 al 21 luglio 2023 n. 69.000 azioni ordinarie (pari allo 0,037% del capitale sociale) al prezzo medio ponderato di euro 9,0262 per un controvalore complessivo di euro 622.810,42.

(“TIP” – tip.mi) independent and diversified industrial group specialized in active investment in excellent companies, listed on the Euronext STAR Milan (LEI code no. 81560017CF8066680595) in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 27, 2023 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 69,000 TIP S.p.A. ordinary shares (equal to 0.037% of share capital) throughout July 17, 2023, to July 21, 2023, at a weighted average price of 9.0262 Euro, at the countervalue of 622,810.42 Euro.

Purchases were made through the intermediary Equita Sim S.p.A. (code LEI 815600E3E9BFBC8FAA85).
