(codice LEI 81560017CF8066680595) che partecipa al capitale di numerose eccellenze imprenditoriali, comunica di aver acquistato sul mercato Euronext Milan, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 27 aprile 2023 (già oggetto di informativa anche ai sensi dell’art.144 bis del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 2 ottobre 2023 al 6 ottobre 2023 n. 48.430 azioni ordinarie (pari allo 0,026% del capitale sociale) al prezzo medio ponderato di euro 8,3003 per un controvalore complessivo di euro 401.985,17.

Tamburi Investment Partners S.p.A. (“TIP” – tip.mi), independent and diversified industrial group listed on the Euronext STAR Milan segment of Borsa Italiana S.p.A. (LEI code no. 81560017CF8066680595) participating in several excellent entrepreneurial companies, in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 27, 2023 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 48,430 TIP S.p.A. ordinary shares (equal to 0.026% of share capital) throughout October 2, 2023, to October 6, 2023, at a weighted average price of 8.3003 Euro, at the countervalue of 401,985.17 Euro.
