(LEI code no. 81560017CF8066680595) participating in several excellent entrepreneurial companies, in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 27, 2023 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 77,166 TIP S.p.A. ordinary shares (equal to 0.042% of share capital) throughout October 9, 2023, to October 13, 2023, at a weighted average price of 8.2245 Euro, at the countervalue of 634,653.84 Euro.
