(LEI code no. 81560017CF8066680595) which invests in excellent entrepreneurial companies, in execution of the treasury shares program declares the acquisition on the Euronext Milan market, according to the Shareholders’ Meeting on April 29, 2024 approval, (already announced in according to article 132 of “Testo Unico della Finanza” and article 144 – bis, paragraph 1, letter b, of Consob Regulation no. 11971 of May, 1999) of n. 60,595 TIP S.p.A. ordinary shares (equal to 0.033% of share capital) throughout July 29, 2024, to August 2, 2024, at a weighted average price of 9.1034 Euro, at the countervalue of 551,622.95 Euro.
