(codice LEI 81560017CF8066680595) che investe nelle eccellenze imprenditoriali, comunica di aver acquistato sul mercato Euronext Milan, nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea del 29 aprile 2025 (già oggetto di informativa anche ai sensi dell’art. 144-*bis*, comma 1 lettera b), del Regolamento Consob 11971/99 e dell’art. 132 del D.Lgs. n. 58/98) nel periodo dal 10 novembre 2025 al 14 novembre 2025 n. 117.339 azioni ordinarie (pari allo 0,064% del capitale sociale) al prezzo medio ponderato di euro 8,4411 per un controvalore complessivo di euro 990.464,69.
