The Group was chosen to ensure regulatory compliance and end-to-end traceability in the cosmetics supply chain, with scalable management of billions of products, real-time data exchange, and digital reporting

The system features a set of integrated functionalities that enable brands to access easily scalable solutions, aligned with the needs of a constantly evolving market, where data plays a central role. Built on the *rfxcel* platform, the solution will serve as a **centralized serialization engine** (L4), able to **seamlessly integrate with the customer's production systems** (L3) and with **external regulatory platforms** (L5). Designed to fulfill the strictest safety and integration with existing processes, the platform has been structured to **manage large volumes of serialized data** and to **guarantee real-time compliance in different markets and product categories**.

The key features of the platform include:

- Scalable management of serialization for billions of unique product identities.
- Real-time data exchange between production warehouses, carriers and customs systems.
- Use of open protocols and industry standards for data exchange.
- Full support for aggregation, verification and digital compliance reports.
