On July 20, 2026, Barrick entered into a subscription agreement with Kingfisher (the “**Subscription Agreement**”) pursuant to which Barrick agreed to subscribe for 15,470,934 units (“**Units**”) of Kingfisher at a price of C\$1.35 per Unit for total consideration of C\$20,885,760.90 pursuant to a non-brokered private placement of Units by Kingfisher (the “**Private Placement**”). Each Unit is comprised of one Common Share and one-half of a purchase warrant (a “**Warrant**”). Each whole Warrant will entitle the holder to acquire one Common Share at a price of C\$1.70 for a period of two years from the closing date of the Private Placement. The Private Placement is subject to certain closing conditions, including approval of the TSX Venture Exchange, and is expected to close on or about July 27, 2026.

Prior to entering into the Subscription Agreement, Barrick did not own any Common Shares or Warrants of Kingfisher.

Immediately following closing of the Private Placement, Barrick is expected to own 15,470,934 Common Shares and 7,735,467 Warrants, representing approximately 9.9% of the issued and outstanding Common Shares on a non-diluted basis, and 14.1% of the outstanding Common Shares on a partially-diluted basis (assuming exercise of all the Warrants held by Barrick).

Barrick acquired the Common Shares and Warrants for investment purposes. Barrick may, from time to time, subject to any applicable legal requirements, acquire additional Common Shares or other securities of Kingfisher or dispose of some or all of the Common Shares, Warrants or other securities of Kingfisher that it owns at such time. Barrick currently has no other plans or intentions that relate to or would result in any of the actions listed in items (a) to (k) above, but depending on market conditions, general economic and industry conditions, trading prices of Kingfisher's securities, Kingfisher's business, financial condition and prospects and/or other relevant factors, Barrick may develop such plans or intentions in the future.

In connection with the Private Placement, Barrick and Kingfisher entered into an investor rights agreement (the "**Investor Rights Agreement**"). Under the Investor Rights Agreement, provided that Barrick maintains an ownership interest in Kingfisher of at least 5%, Barrick is entitled to (a) participate in equity financings and to top-up its holdings in relation to specified dilutive issuances in order to maintain its *pro rata* ownership in Kingfisher, and (b) information rights entitling it to receive certain data regarding Kingfisher's Highway 37 Project. In addition, Kingfisher will not, without Barrick's prior written consent, transfer any direct or indirect interest in its Highway 37 Project, subject to certain exceptions, provided that Barrick maintains an ownership interest of at least 5%. Barrick also agreed, for a period of 24 months from the date of the Investor Rights Agreement, to vote its Common Shares in accordance with the recommendations of the board or management of Kingfisher, or to abstain from voting on such matters, and to be subject to a standstill which will prohibit Barrick from acquiring more than 15% of the outstanding Common Shares (increasing to 19.9% if a third party acquires 10% or more of the Common Shares on a partially-diluted basis during the standstill period), subject to certain exceptions.
