This document does not provide full disclosure of all material facts relating to the securities offered and investors should read the Prospectus, and any amendments or supplements thereto, for disclosure of those facts, especially risk factors relating to the securities offered, before making an investment decision. KEY TERMS

Issuer:	The Bank of Nova Scotia (the "Bank").
Reference ETF**:	SPDR® S&P® Biotech ETF (the "Reference ETF").
Monthly Coupon Payments:	Holders of record on the applicable Monthly Coupon Payment Record Date may be entitled to receive from the Bank a Monthly Coupon Payment, determined as follows: If the Closing Unit Price on the relevant Monthly Coupon Payment Valuation Date is greater than the Barrier Price: the Monthly Coupon Payment will be \$0.92 per Note. If the Closing Unit Price on the relevant Monthly Coupon Payment Valuation Date is less than or equal to the Barrier Price: no Monthly Coupon Payment will be made. The aggregate Monthly Coupon Payments over the term of the Notes will not exceed \$55.20 per Note. If the Notes are called, holders will receive both the Principal Amount and the Monthly Coupon Payment for the applicable Autocall Valuation Date.
Autocall:	105.00% of the Initial Unit Price. The Notes will be automatically called (i.e., redeemed) by the Bank if the Closing Unit Price on any Autocall Valuation Date is greater than or equal to the Autocall Price. *The Notes cannot be automatically called prior to March 1, 2021. If the Closing Unit Price on any Autocall Valuation Date is not greater than or equal to the Autocall Price, the Notes will not be automatically called by the Bank. Investors should note that the automatic call feature is monthly.
Contingent Protection:	30.00% contingent protection. The Notes provide contingent principal protection at maturity if the Final Unit Price on the Final Valuation Date is greater than the Barrier Price (which is 70.00% of the Initial Unit Price). If the Final Unit Price on the Final Valuation Date is equal to or less than the Barrier Price, a holder of the Notes will be fully exposed to any negative price performance of the Reference Unit, meaning that substantially all of such holder's investment may be lost (subject to a minimum principal repayment of \$1.00 per Note).

Coupon Payment Valuation Dates, Record Dates and Payment Dates:	The specific Monthly Coupon Payment Valuation Dates, Monthly Coupon Payment Record Dates and Monthly Coupon Payment Dates for the Notes are set forth in the pricing supplement (see "Monthly Coupon Payments" in the pricing supplement), subject to the Notes being automatically called by the Bank and to the occurrence of any special circumstances (see "Special Circumstances" in the pricing supplement).
Maturity Redemption Amount:	Holders of record on the applicable Record Date will be entitled to an amount payable per Note if they are automatically called by the Bank or at maturity (in each case, the "Maturity Redemption Amount") as calculated by the Calculation Agent in accordance with the applicable formula below: If the Closing Unit Price on an Autocall Valuation Date or the Final Valuation Date is greater than or equal to the Autocall Price, the Maturity Redemption Amount will equal: Principal Amount If the Final Unit Price on the Final Valuation Date is less than the Autocall Price but greater than the Barrier Price, the Maturity Redemption Amount will equal: Principal Amount If the Final Unit Price on the Final Valuation Date is equal to or less than the Barrier Price, the Maturity Redemption Amount will equal: Principal Amount + (Principal Amount x Price Return) The Maturity Redemption Amount will be substantially less than the Principal Amount invested by an investor if the Final Unit Price on the Final Valuation Date is equal to or less than the Barrier Price. Price Return:	The Price Return is an amount expressed as a percentage (which can be zero, positive or negative) calculated by the Calculation Agent in accordance with the following formula: (Final Unit Price – Initial Unit Price) / Initial Unit Price
Closing Unit Price:	The official closing price or value of the Reference Unit on a given day as calculated and announced by the Exchange on an Exchange Business Day.
Initial Unit Price:	The Closing Unit Price on the Initial Valuation Date.
Final Unit Price:	The Closing Unit Price on an Autocall Valuation Date or the Final Valuation Date, as the case may be.
Currency:	The Notes are denominated in Canadian dollars. The return on the Notes in Canadian dollars will be based solely upon the Closing Unit Price on a Monthly Coupon Payment Valuation Date, an Autocall Valuation Date or the Final Valuation Date, as the case may be. Accordingly, the Maturity Redemption Amount and any Monthly Coupon Payments payable in respect of the Notes will be unaffected by changes in the exchange rate of the Canadian dollar relative to any other currency.

Listing and Secondary Market:	The Notes will not be listed on any exchange or marketplace. Scotia Capital Inc. will use reasonable efforts under normal market conditions to provide a daily secondary market for the sale of the Notes but reserves the right to elect not to do so at any time in the future, in its sole and absolute discretion, without prior notice to holders.
Eligibility for Investment:	Eligible for RRSPs, RRIFs, RESPs, RDSPs, DPSPs and TFSAs.
Fees and Expenses:	There is no selling concession fee payable to the Investment Dealers in respect of the Notes. A fee of up to \$0.15 per Note sold (or up to 0.15% of the Principal Amount) will be payable directly by the Bank to Industrial Alliance Securities Inc. at closing for acting as the independent agent. The payment of these fees will not reduce the amount on which the Maturity Redemption Amount payable on the Notes is calculated. The return on the Reference Unit and on the Notes will be affected by the management expense ratio (the "MER") which reflects the ongoing costs of the Reference ETF, including the annual management fee payable by the Reference ETF to the ETF Advisor in the amount of 0.35%, which amount does not reflect transaction costs payable by the Reference ETF, such as brokerage commissions payable on purchases and sales of the securities held by the Reference ETF. The MER, as reported by the ETF Advisor as at June 30, 2020, represented 0.35% of the Reference ETF's net asset value.

HYPOTHETICAL EXAMPLES

The following examples show how the Price Return and Maturity Redemption Amount would be calculated based on certain hypothetical values and assumptions set out below. **These examples are for illustrative purposes only and should not be construed as an estimate or forecast of the performance of the Reference Unit or the return that an investor might realize on the Notes.** The Price Return will be calculated based on the price performance of the Reference Unit, which will not reflect the value of any dividends, distributions or other income or amounts accruing or paid on the constituent securities of the Reference ETF. Certain dollar amounts are rounded to the nearest whole cent and "\$" refers to the relevant currency for the specific hypothetical dollar amounts and hypothetical prices that the context requires.

Hypothetical values for calculations:

Initial Unit Price*:	\$100.00		
Barrier Price:	70.00% of the Initial Unit Price =	70.00% x \$100.00 =	\$70.00
Autocall Price:	105.00% of the Initial Unit Price =	105.00% x \$100.00 =	\$105.00

*The Initial Unit Price of \$100.00 is a hypothetical Initial Unit Price that has been chosen for illustrative purposes only and does not represent either the actual Initial Unit Price or an estimate or forecast thereof. The actual Initial Unit Price will be equal to the Closing Unit Price on the Initial Valuation Date.

Example #1 – The Notes are not automatically called as the Closing Unit Price on each Autocall Valuation Date is less than the Autocall Price. The Final Unit Price on the Final Valuation Date is equal to or less than the Barrier Price.

Since the Final Unit Price (\$56.00) on the Final Valuation Date is less than the Barrier Price (\$70.00), the Maturity Redemption Amount is calculated as follows:

Principal Amount + (Principal Amount x Price Return)

$$\$100.00 + (\$100.00 \times -44.00\%) = \$56.00 \text{ per Note}$$

In this example, since the Closing Unit Price is less than the Barrier Price on all Monthly Coupon Payment Valuation Dates, an investor would not receive any Monthly Coupon Payments.

An investor would receive a Maturity Redemption Amount of \$56.00 per Note on the Maturity Date, which is equivalent to an annual compound rate of return of approximately -10.95% per Note.

Example #2 – The Notes are not automatically called as the Closing Unit Price on each Autocall Valuation Date is less than the Autocall Price. The Final Unit Price on the Final Valuation Date is less than the Autocall Price, but greater than the Barrier Price.



Time From Issue Date (in Months) and Valuation Dates

Since the Final Unit Price (\$81.00) on the Final Valuation Date is less than the Autocall Price (\$105.00), but greater than the Barrier Price (\$70.00), the Maturity Redemption Amount is calculated as follows:

Principal Amount

\$100.00 per Note

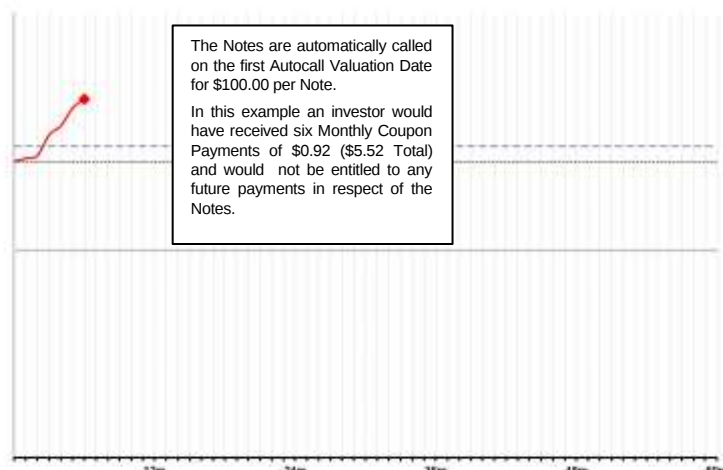
In this example, an investor would receive Monthly Coupon Payments for each of the first thirty Monthly Coupon Payment Valuation Dates and for each of the 55th to the 60th Monthly Coupon Payment Valuation Dates, but would not receive any Monthly Coupon Payments for the 31st to the 54th Monthly Coupon Payment Valuation Dates since the Closing Unit Price on each such Monthly Coupon Payment Valuation Date is less than the Barrier Price.

An investor would receive aggregate Monthly Coupon Payments of \$33.12 per Note, and a Maturity Redemption Amount of \$100.00 per Note, on the Maturity Date, which is equivalent to an annual compound rate of return of approximately 5.89% per Note.

Example #3 – The Notes are automatically called on the first Autocall Valuation Date as the Closing Unit Price on the first Autocall Valuation Date is greater than or equal to the Autocall Price.



Time From Issue Date (in Months) and Valuation Dates

Since the Closing Unit Price (\$121.00) on the first Autocall Valuation Date is greater than the Autocall Price (\$105.00), the Maturity Redemption Amount is calculated as follows:

In this example, since the Closing Unit Price is greater than the Barrier Price on each applicable Monthly Coupon Payment Valuation Date, an investor would receive Monthly Coupon Payments of \$0.92 per Note on each of the first six Monthly Coupon Payment Dates.

An investor would receive aggregate Monthly Coupon Payments of \$5.52 per Note, and a Maturity Redemption Amount of \$100.00 per Note, which is equivalent to an annual compound rate of return of 11.34% per Note.

HISTORICAL PERFORMANCE
