On March 28, 2022, the Acquiror purchased 249,000 common shares through the facilities of the Toronto Stock Exchange.

The Acquiror acquired ownership and control of 249,000 common shares. The common shares represented approximately 0.29% of all issued and outstanding common shares of the Corporation as of March 28, 2022 immediately following the transaction described above, resulting in a

corresponding increase in the percentage of shares held by the Acquiror as a result of the transaction.

The Acquiror acquired ownership.

Prior to the completion of the acquisition, the Acquiror, together with its joint actors, Mr. Cudney and Cudney Stables Inc., collectively owned and controlled an aggregate of 14,478,123 common shares of the Corporation (of which 14,246,142 common shares are owned by the Acquiror directly, 36,000 common shares are owned by Cudney Stables Inc., and 195,981 common shares are owned by Mr. Cudney) and convertible securities entitling the Acquiror and its joint actors to acquire an additional 510,000 common shares of the Corporation (of which 460,000 convertible securities are owned by the Acquiror directly and 50,000 convertible securities are owned by Mr. Cudney) representing approximately 16.71% of the issued and outstanding common shares of the Corporation as of March 28, 2022 (or approximately 17.20% calculated on a partially diluted basis, assuming the exercise of the 510,000 convertible securities only).

Upon completion of the acquisition, the Acquiror, together with its joint actors, Mr. Cudney and Cudney Stables Inc., collectively own and control an aggregate of 14,727,123 common shares of the Corporation (of which 14,495,142 common shares are owned by the Acquiror directly, 36,000 common shares are owned by Cudney Stables Inc., and 195,981 common shares are owned by Mr. Cudney) and convertible securities entitling Northfield and its joint actors to acquire an additional 510,000 common shares of the Corporation (of which 460,000 convertible securities are owned by the Acquiror directly and 50,000 convertible securities are owned by Mr. Cudney) representing approximately 17.00% of the issued and outstanding common shares of the Corporation as of March 28, 2022 immediately following the transaction described above (or approximately 17.48% calculated on a partially diluted basis, assuming the exercise of the 510,000 convertible securities only).

The aggregate consideration payable for the common shares acquired on March 28, 2022 was \$216,319, calculated as an aggregate of 249,000 common shares at a price of \$0.87 per common share.
