The requirement to file this report was triggered on November 30, 2020 due to the dispositions of the Shares of the Issuer by Fiera, on behalf of funds and accounts over which it manages, during the month of November. Since the last report filed for the month ended April 2019, Fiera sold in total of 2,464,691 Shares of the Issuer.
