Sant'Agata Feltria (Rimini), 18 novembre 2020 – Indel B S.p.A. – società quotata all'MTA di Borsa Italiana, a capo di un gruppo attivo nella produzione di sistemi di refrigerazione e condizionamento per il mobile e mobile living per i mercati automotive, hospitality e leisure time (nautica da diporto e recreational vehicles), – nell'ambito del programma di acquisto di azioni proprie comunicato al mercato in data 4 giugno 2020 e avviato in data 06 luglio 2020 sino ad un massimo di n. 200.000 azioni ordinarie, – ai sensi e per gli effetti dell'art. 5 del Regolamento (UE) n. 596/2014, e dell'art. 2, paragrafo 3, del Regolamento Delegato (UE) n. 2016/1052 della Commissione dell'8 marzo 2016 – di aver acquistato sul Mercato Telematico Azionario (MTA) organizzato e gestito da Borsa Italiana S.p.A., nel periodo compreso tra il 12 novembre e il 18 novembre 2020, complessive n. 2.540 azioni proprie (corrispondenti allo 0,043% del numero complessivo di azioni ordinarie), al prezzo medio ponderato di Euro 18,0890 per un controvalore titoli complessivo pari a Euro 45.946,15.

Sant'Agata Feltria (Rimini), 18 November 2020 – **Indel B S.p.A.** - a company listed on the Borsa Italiana MTA and parent of a group that operates in the manufacture of cooling systems and air-conditioning for mobile and mobile living for the automotive, hospitality and leisure time markets (pleasure boats and recreational vehicles) – under the buyback program of treasury shares announced to the market on June 4, 2020, and launched on July 6, 2020 up to n. 200,000 ordinary shares, announces – according to the provision and for the purpose of Article 5 of Regulation (EU) 596/2014 and Article 2, paragraph 3, of the Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 – to have acquired on the Mercato Telematico Azionario (MTA) organized and managed by Borsa Italiana S.p.A., in the period from 12th November to 18th November 2020, total n. 2,540 of treasury shares (corresponding to 0.043% of the total number of ordinary shares), at a weight average price of Euro 18.0890 for a total counter-value of Euro 45,946.15.
