Sant'Agata Feltria (Rimini), 28 giugno 2021 – **Indel B S.p.A.** – società quotata all'MTA di Borsa Italiana, a capo di un gruppo attivo nella produzione di sistemi di refrigerazione e condizionamento per il *mobile* e *mobile living* per i mercati *automotive*, *hospitality* e *leisure time* (nautica da diporto e *recreational vehicles*), – nell'ambito del programma di acquisto di azioni proprie approvato dall'Assemblea degli Azionisti in data 21 maggio 2021 e deliberato dal Consiglio di Amministrazione in data 18 giugno 2021 sino ad un massimo di n. 125.000 azioni ordinarie – ai sensi e per gli effetti dell'art. 5 del Regolamento (UE) n. 596/2014, e dell'art. 2, paragrafo 3, del Regolamento Delegato (UE) n. 2016/1052 della Commissione dell'8 marzo 2016 – di aver acquistato sul Mercato Telematico Azionario (MTA) organizzato e gestito da Borsa Italiana S.p.A., nel periodo compreso tra il 22 giugno e il 28 giugno 2021 complessive n. 1.937 azioni proprie (corrispondenti allo 0,033% del numero complessivo di azioni ordinarie), al prezzo medio ponderato di Euro 26,2204 per un controvalore titoli complessivo pari a Euro 50.789,00.

Sant'Agata Feltria (Rimini), 28 June 2021 – **Indel B S.p.A.** - a company listed on the Borsa Italiana MTA and parent of a group that operates in the manufacture of cooling systems and air-conditioning for mobile and mobile living for the automotive, hospitality and leisure time markets (pleasure boats and recreational vehicles) – under the buyback program of treasury shares announced to the market on May 21, 2021 and approved by the Board of Directors on June 18, 2021 up to n. 125,000 ordinary shares – according to the provision and for the purpose of Article 5 of Regulation (EU) 596/2014 and Article 2, paragraph 3, of the Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 – announces to have acquired on the Mercato Telematico Azionario (MTA) organized and managed by Borsa Italiana S.p.A., in the period from 22nd June to 28th June 2021, total n. 1,937 of treasury shares (corresponding to 0.033% of the total number of ordinary shares), at a weight average price of Euro 26.2204 for a total counter-value of Euro 50,789.00.
