PRIVATE PLACEMENT AND SHARES FOR DEBT CLOSE

Abacus Minerals Corporation (the “Company”) announces the private placement, previously announced February 17, 2000, has closed to raise proceeds of \$115,000. Each unit consists of one common share and one common share purchase warrant of the Company. One whole share purchase warrant is exercisable into one common share at price of \$0.10 in year one and \$0.15 in year two.

The common shares and any shares issue pursuant to the exercise of the warrants will be subject to a four-month hold period expiring August 4, 2000.
