

Cosmetics: CDP Grants Intercos EUR 60 Million for New Investments in Research, Innovation, and Sustainability

A new cosmetics production center, a scientific hub, and a photovoltaic plant are among the investments planned by the Agrate Brianza-company.

The completion of these projects will allow the Group to continue its growth and consolidate its leadership in the field of innovation, also generating a positive impact on employment levels.

Milan, July 9, 2024 – Investments for the digital transition, innovation, and the environment with the creation of a new cosmetics production center, a scientific hub, and a photovoltaic plant. The financing of **EUR 60 million** from **Cassa Depositi e Prestiti** granted to **Intercos**, a leading group in the development and production of cosmetics at international level, will be allocated to these objectives.

In detail, CDP's resources will be assigned to the construction of the new industrial center dedicated to make-up that will be located in Agrate Brianza and Caponago and will follow two main directives:

- **Research and innovation**, with the creation of a cosmetics center that will further increase research and development activities, create a new scientific hub for the enhancement of laboratory activities, and build a highly digitalized production plant with innovative processes;
- **Environment and energy**, with the installation of a photovoltaic plant capable of making the new facility extremely energy efficient.

All Intercos's investments, thanks also to CDP's support, will allow the Group to consolidate current quality levels and further increase the Group's competitiveness in the global market. The completion of the project will also have significant employment effects as it will lead to the direct hiring of new staff to be employed mainly at the production site, in the new research and development department, and in the scientific hub.

The operation contributes to the pursuit of the eighth goal of the United Nations 2030 Agenda for Sustainable Development and is also in line with the indications reported in [CDP's Strategic Sector Guidelines](#).
