## SHARE BUY BACK

Reggio Emilia, 4 July 2025 – NewPrinces S.p.A. (the "**Company**" or "**NewPrinces**") announces that, following the authorizations of the purchase and disposal of own shares by the Shareholders' Meeting of 28 April 2025, in the period from 1 June to 30 June 2025, the Company bought back a total of 110,052 ordinary shares on the Mercato Telematico Azionario (equal to 0.25% of the share capital) at an average share price of  $\notin$  17.14 and for a total value of  $\notin$  1,893,446.14.
