



**UPDATE ON THE EXECUTION OF SAFILO GROUP S.P.A.
SHARES PURCHASE PROGRAMME
DURING THE PERIOD FROM NOVEMBER 10, 2025 TO NOVEMBER 14, 2025**

Padua – November 18, 2025 - In the context of the purchase programme of Safilo Group S.p.A. ordinary shares communicated to the market on June 24, 2025 and launched on June 25, 2025 (the **"Programme"**), as per the authorization granted by the Shareholders' Meeting of Safilo S.p.A. (the **"Company"**) held on April 24, 2025 – according to the information received from Kepler Cheuvreux as intermediary in charge of executing, in full independence, the Programme – the Company informs, pursuant to art. 2, paragraph 3, of the Delegated Regulation (EU) no. 1052/2016, that it has carried out the transactions indicated below.

The chart below provides in aggregate form and on a daily basis the purchases of Safilo Group ordinary shares (ISIN IT0004604762) carried out by the Company on the *Euronext Milan* market, organized and managed by Borsa Italiana S.p.A., in the period from November 10, 2025 to November 14, 2025.

As of November 14, 2025 the Company has purchased, since the launch of the Programme, a total number of 11,302,492 of Safilo Group ordinary shares and therefore, taking into consideration the shares already owned, it holds a total number of 22,302,492 of Safilo Group ordinary shares, equal to approximately 5.38% of the outstanding shares.
