1. The name of the Reporting Issuer is **Goldhunter Explorations Inc.** (the "Company") whose principal office is at **Suite 402, 111 Richmond Street West, Toronto, Ontario M5H 2G4**
2. The material change occurred on November 29, 2000.
3. A Press Release was published at Toronto on November 29, 2000.
4. On November 29, 2000 the Company announced it had mutually agreed with Sportscalc.com Ltd. ("Sportscalc") to terminate negotiations towards a take-over bid for Sportscalc by the Company as disclosed in the Company's press release of August 28, 2000. The Company stated that market conditions had made the transaction unviable at this time.
5. The Company announced that it intends to pursue opportunities in the resource sector. The Company will review its current holdings with a view to determining whether or not to pursue further exploration on its properties. The Company intends to pursue the acquisition of other precious and base metal exploration properties.

Trading of the common shares of the Company will recommence following a review of the Company by the Tier Maintenance division of the Canadian Venture Exchange.

6. This report is not being filed on a confidential basis in reliance on subsection 75(3) of the Ontario Securities Act.
