(**Italmobiliare** o la **Società**) comunica che, nell'ambito del programma di acquisto di azioni proprie (il Programma), effettuato a valere sulla delibera dell'assemblea degli azionisti del 17 aprile 2025, annunciato il 30 giugno 2025 e avviato il 3 luglio 2025, dal 15 settembre 2025 al 19 settembre 2025 sono state acquistate complessivamente sul segmento Euronext STAR Milan - Borsa Italiana, n. 22.740 azioni, pari allo 0,054% del capitale, a un prezzo medio unitario di euro 29,8406 per azione, e per un controvalore complessivo di euro 678.576,05.

UPDATE ON THE EXECUTION OF THE BUY BACK PROGRAM

Milan, September 22, 2025 – Italmobiliare S.p.A. (**Italmobiliare** or **the Company**) announces that under the treasury share buyback program (the Program) carried out according to the resolution taken by the shareholders' meeting on April 17, 2025, announced on June 30, 2025 and launched on July 3, 2025, from September 15, 2025 to September 19, 2025, a total of 22,740 shares, equal to 0.054% of the issued share capital, were purchased on Euronext STAR Milan - Borsa Italiana at an average price per share of euro 29.8406 and for a total countervalue of 678,576.05 euro.

On the basis of the information provided by the intermediary in charge of implementing the Program in full independence, the details of the transactions on a daily basis in aggregated form are given below.
