Milano, 30 settembre 2025 - Italmobiliare comunica che nell'ambito del programma di acquisto di azioni proprie (il Programma) effettuato a valere sulla delibera dell'assemblea degli azionisti del 17 aprile 2025, annunciato il 30 giugno 2025 e avviato il 3 luglio 2025, dal 22 settembre al 30 settembre 2025 sono state acquistate complessivamente sul segmento Euronext STAR Milan – Borsa Italiana, n. 35.500 azioni, pari allo 0,084% del capitale, a un prezzo medio unitario di euro 30,0709 per azione, e per un controvalore complessivo di euro 1.067.516,45.

UPDATE ON THE EXECUTION AND CONCLUSION OF THE BUY BACK PROGRAM

Milan, September 30, 2025 – Italmobiliare (**Italmobiliare** or **the Company**) announces that under the treasury share buyback program (the Program), carried out according to the resolution taken by the shareholders' meeting on April 17, 2025, announced on June 30, 2025 and launched on July 3, 2025, from September 22, 2025 to September 30, 2025, a total of 35,500 shares, equal to 0.084% of the issued share capital, were purchased on Euronext STAR Milan – Borsa Italiana at an average price per share of euro 30.0709 and for a total countervalue of 1,067,516.45 euro.

On the basis of the information provided by the intermediary in charge of implementing the Program in full independence, the details of the transactions on a daily basis in aggregated form are given below. Details of the transactions carried out during the period are attached.

The Program ends today, with the total purchase from July 3, 2025, to September 30, 2025, of 210,905 shares (0.496% of the share capital) at an average unit price of euro 28.7168 per share, for a total value of 6,056,509.85. The Program concerned the purchase up to a maximum of 350,000 shares, corresponding to 0.824% of the issuer's share capital, for a maximum consideration of euro 10,000,000.

As of today, the Company holds a total of 427,975 treasury shares representing 1.007% of the share capital.
