**Circle GROUP announces a new contract with one of Italy's leading transport companies for advanced interoperability, sustainability and digitalisation of intermodal logistics, worth almost €200,000.**

[Circle S.p.A.](#) ("CIRCLE" or the "Company") - an Innovative SME listed on the **Euronext Growth Milan market**, heading the Group specialized in the process analysis and the development of solutions for the digitalisation of the port and intermodal logistics sectors, as well as in the international consultancy on Green Deal and energy transition topics – announces a new agreement to drive innovation in intermodal logistics through the **MILOS®** federated ecosystem, with a new project for **one of Italy's leading intermodal transport companies**, worth approximately **€200,000** and lasting 12 months. The initiative stands out for its high level of interoperability, integration with key logistics hubs and full compliance with European regulations on transport digitalisation.

The project is part of an ongoing management evolution process, which involves the progressive integration of TMS and management systems with the **MILOS® TFP platform**. This platform enables the exchange of digital information between logistics operators, ports, terminals and transport partners, facilitating simplified interconnection with the main Italian port and intermodal hubs.

The initiative will enable the digitalisation of transport documents through the integration of the **e-CMR/e-DDT connector (Accudire ExAc)** – the digital versions of the consignment note and transport documents, respectively – as well as the provision of the **eFTI Platform**, in accordance with the European eFTI Regulation (EU 1056/2020). These services will ensure **fully electronic management of document flows** between management systems, logistics partners and control authorities, enabling not only regulatory compliance but also effective operational efficiency throughout the supply chain.

The project also includes integration with partners already interoperable within the MILOS® ecosystem, such as shipowners and shipping agencies, and railway companies for efficient and digital management of intermodality. Interconnection with vehicle monitoring systems (primarily **KMaster**) will extend control to vehicles in motion, including sub-carriers and third-



party suppliers.

A distinctive feature of this modernisation will be the possible future use of **federated infomobility services**, which will make it possible to obtain **qualified ETAs** based on real-time road traffic, improving the planning and execution of transport and logistics missions, even during the operational phase.

At the same time, by June 2026, PNRR programmes and projects will continue to support the **digitalisation and interoperability of ports, freight villages and airports** throughout the country. This systemic context provides a further stimulus for the adoption of federative platforms such as MILOS, designed to harmonise dialogue between public and private operators, with open, scalable solutions that comply with the main international standards (EDIFACT, EDIGES, e-CMR, H30, TAF TSI, e-CIM, etc.).

Circle Group therefore provides the entire logistics ecosystem with a complete suite of interoperable digital tools, designed to maximise efficiency, reduce waiting times, increase the transparency of operations and provide concrete support for the digital and sustainable transition of the supply chain.

*"Digital interoperability is the key to sustainable, efficient logistics that complies with European regulations and is in line with the **"Connect 4 Agile Growth"** industrial plan. *Finally, through **NEXT Customs**, active in customs optimisation digital services and functional to the continuation of initiatives aimed at the harmonisation of customs processes, Circle has entered a strongly strategic sphere for the evolution of the **Connect 4 Agile Growth** path.*
