Earnings Coverage

The earnings coverage ratio for long-term debt and current liabilities for the twelve months ended June 30, 2019, was 2.99 times.

The earnings coverage ratio is calculated as: Earnings for the respective twelve month period before interest expense and income taxes, divided by interest expense and interest capitalized.
