Earnings Coverage

The earnings coverage ratio for long-term debt and current liabilities for the twelve months ended December 31, 2024, was 2.16 times.

The earnings coverage ratio is calculated as: Earnings for the respective twelve month period before interest expense and income taxes, divided by interest expense and interest capitalized.
