

Concerned Aberdeen Shareholders Recommend GOLD Proxy Before Time Runs Out, Expose Aberdeen's Misleading Statements

TORONTO, ON Jan 20, 2015 - Today, funds controlled by Meson Capital Partners LLC ("Meson Capital") and Nightscape Capital (UK) LLP ("Nightscape Capital") that hold shares representing approximately 9% of the issued and outstanding shares of Aberdeen International Inc. (TSX: AAB) ("Aberdeen" or the "Company") urge fellow shareholders to vote for change at Aberdeen with the GOLD form of proxy before time runs out.

The attached letter highlights the Concerned Shareholder's specific action plan for change that will END insider self-dealing and put cash back in the hands of investors while debunking the numerous misleading statements made by Aberdeen insiders.

Highlights of the Letter Include:

- FACT: Leading independent proxy advisory research firm ISS recommends investors vote the GOLD Proxy card and DO NOT vote Management's BLUE card.
- FACT: Concerned Shareholders are NOT engaged in vote buying as has been falsely accused by Aberdeen Management, meanwhile Aberdeen Management has failed to confirm that it will not be engaging in vote buying itself
- FACT: Ryan Morris and Meson Capital have had +250% better investment returns than Aberdeen International and have extensive experience creating shareholder value with active involvement: HearUSA: +206%; InfuSystem: +192%; Sevcon: +52%
- FACT: The Concerned Shareholders are not proposing a fire sale of assets but instead have a detailed plan to maximize value for ALL shareholders
- FACT: The Concerned Shareholder nominees can and will convene a board meeting if elected.
- FACT: With the looming threat of an election, in November Aberdeen completed a private placement 100% to insiders and related parties, while attempting to obfuscate this fact using a numbered corporation, to try to dilute YOUR vote

The Concerned Shareholders further detail their specific plan that will:

- 1) Dramatically lower insider compensation by over 80%
- 2) Cease related party self-dealing
- 3) Immediately return \$0.15 cash directly to shareholders
