VARAS S.P.A. CROSSES THE THRESHOLD OF 66.67% OF THE SARAS S.P.A.'S SHARE CAPITAL AND CURRENTLY IS AT 79.719% OF SARAS S.P.A.'S SHARE CAPITAL

Milan, 9 August 2024 – With reference to the mandatory tender offer promoted by Varas S.p.A. (the "Offeror") pursuant to Articles 102 and 106, paragraph 1, of the Legislative Decree 24 February 1998, no. 58 (the "Offer") on the ordinary shares of Saras S.p.A. ("Saras" or the "Issuer"), the Offeror announces that it has exceeded, based on the acceptances received on the date hereof, the threshold of 66.67% Issuer's share capital, and will come to hold, as a result of the Offer, a total of no. 758,125,552 of Saras shares, equal to 79.719% of the Issuer's share capital (considering no. 281,439,568 Saras' shares, equal to 29.594% of the Issuer's share capital, tendered to the Offer until August 9, 2024, and no. 476,685,984 Saras' shares already held by the Offeror, equal to 50.125% of the Issuer's share capital).

The initial acceptance period of the Offer, as extended by a press release of the Offeror on 8 August 2024 (available for consultation, *inter alia*, on the Issuer's website www.saras.it), will expire on August 16, 2024. However, the acceptance period, as extended, shall be reopened, pursuant to and for the purposes of Article 40-bis, paragraph 1, let. b), number 1), of the Issuers' Regulation, for the sessions of 26 August 2024, 27 August 2024, 28 August 2024, 29 August 2024 and 30 August 2024.

The Offer is aimed at the acquisition of the entire share capital of the Issuer and, in any event, at the delisting of the Issuer from the Euronext Milan. As indicated in the offer document approved by CONSOB with resolution no. 23188 of 10 July 2024 and published on 11 July 2024 (the "Offer Document"), if the requirements for delisting are not achieved as a result of the Offer, the Offeror reserves the right to achieve the delisting by other means, including the merger by incorporation of the Issuer into the Offeror (an unlisted company) (the "Merger for the Delisting").

In particular, as a result of crossing the 66.67% threshold of Saras' share capital in the context of the Offer, the Offeror will hold sufficient shares to ensure, in compliance with the rules of transparency and fairness set forth by the framework on the related parties transactions, the approval of the resolutions at the extraordinary shareholders' meeting, including the Merger for the Delisting (if implemented, at a time of its choosing in respect of the beginning of the merger procedure), with the consequence that the holders of the Issuer's shares who do not exercise their right of withdrawal, pursuant to Article 2437–quinquies of the Italian Civil Code, would become, as a result of the Merger for the Delisting, holders of shares in the capital of an unlisted company.

The Offer will be launched through the publication of the relevant Offer document subject to the approval of Consob. The Offer document will contain the full description of the terms and conditions of the said Offer, including the manner in which it can be accepted.
