Item 4 Summary of Material Change

The Company has closed the **second** tranche of a non-brokered private placement of units to raise a total of \$238,000.

Item 5 Full Description of Material Change

On **May 5, 2011**, the Company closed the **second** tranche of a non-brokered private placement to raise \$238,000. The Company issued **2,975,000** units (the “**Units**”) at a price of **\$0.08** per Unit for gross proceeds of **\$238,000**. Each Unit is comprised of one (1) common share and one (1) common share purchase warrant. Each common share purchase warrant entitles the holder to acquire one common share of the Company for **two (2)** years at a per share price of **\$0.12**.

In addition, the Company paid a Finder’s Fee of cash (**\$1,600**) equal to **8%** of the gross proceeds raised from the sale of **300,000** Units, and issued a Finder’s Fee of **20,000** non-transferable share purchase warrants equal to **8%** from the sale of **250,000** Units.

The issued securities are subject to a **four (4)** month hold period until **September 6, 2011**.
