Leocor is a reporting issuer in the reporting jurisdictions of British Columbia, Alberta and Ontario. The Common Shares are listed on the Canadian Securities Exchange (“**CSE**”) and trade under the trading symbol “LECR” effective June 19, 2019.

Common Shares of the Reporting Issuer acquired pursuant to a private placement of units of the Reporting Issuer (the “**Units**”) completed on March 26, 2026 (the “**Offering**”).

Planet Ventures Inc. (the “**Acquiror**”)

On March 26, 2026, the Acquiror acquired the Units consisting of 20,000,000 Common Shares and 20,000,000 transferable Common Share purchase warrants (“**Warrants**”) upon completion of the Offering (the “**Acquisition**”). As a result of the Acquisition, the Acquiror beneficially owns an aggregate 34,855,083 Common Shares, representing 17.58% of 198,232,402 Common Shares issued and outstanding post-closing of the Offering, on a non-diluted basis, and Warrants exercisable into 24,000,000 Common Shares. The Warrants are subject to a blocker provision providing that the Acquiror shall not be entitled to exercise any Warrants to the extent that, after giving effect to such exercise, the Acquiror would beneficially own more than 20% of the Common Shares issued and outstanding at the time of exercise.

Prior to the Acquisition, the Acquiror beneficially owned 14,855,083 Common Shares, representing approximately 12.56%% of 118,232,402 Common Shares issued and outstanding prior to the closing of the Offering, on a non-diluted basis.

Following the Acquisition on March 26, 2026, the Acquiror beneficially owns 34,855,083 Common Shares, representing approximately 17.58% of 198,232,402 Common Shares issued and outstanding Common Shares post-closing of the Offering, on a non-diluted basis.

As a result of the Acquisition, the Acquiror beneficially owns 34,855,083 Common Shares, representing approximately 17.58% of 198,232,402 Common Shares issued and outstanding Common Shares post-closing of the Offering, on a non-diluted basis.

Following the Acquisition, the Acquiror holds an aggregate 24,000,000 Warrants, each exercisable into one Common Share. On March 26, 2026, the Acquiror entered into a warrant exercise blocker agreement with the Reporting Issuer pursuant to which the Acquiror has agreed not to exercise the

number of Warrants held by the Acquiror that will result in the Acquiror holding 20% of the total issued and outstanding Common Shares of the Reporting Issuer.
