CHANGE OF AUDITOR

VisionQuest Enterprise Group Inc. (the "Company") announces that it has appointed BDO Dunwoody LLP, Chartered Accountants, of Vancouver, British Columbia as its auditors for the 2004 audit replacing T.E. Nikiforuk, Certified General Accountant, of Port Moody, British Columbia. The former auditor resigned as Company auditor of his own initiative, having made a decision not to continue to audit reporting issuers. The Company proposes to have its shareholders ratify and confirm the appointment of BDO Dunwoody LLP, Chartered Accountants at the next Annual General Meeting of the Company.

In accordance with the requirements of National instrument 51-102, following receipt of T.E. Nikiforuk's resignation as auditor, the Company prepared and delivered a Notice of Change of Auditors (the "Notice"). The Notice included the following statements:

"There has been no reportable disagreements with the former auditor and there have been no adverse, qualified, denied or reserved audit opinions contained in the auditors reports on the Company's annual financial statements for the preceding two fiscal years, and there are no similar reservations contained in any auditors' reports or comments on interim financial information for any subsequent period preceding the date of this notice."

The Company has received response letters from BDO Dunwoody LLP, Chartered accountants, the successor auditors, and from T.E. Nikiforuk, Certified General Accountant, the former auditor, both confirming their agreement with the information provided in the Notice.
