Offering:	37,500,000 shares of the Company (the "Common Shares").
Offering Price:	C\$1.20 per Common Share (the "Issue Price").
Offering Size:	Up to C\$45,000,000 (C\$51,750,000 if the Over-Allotment Option (as defined below) is exercised in full).
Type of Transaction:	The Offering will be offered by way of a prospectus supplement to the Company's short form base shelf prospectus dated March 23, 2023 pursuant to National Instrument 44-101 – <i>Short Form Prospectus Distributions</i> and National Instrument 44-102 – <i>Shelf Distributions</i> as filed and to be filed, as applicable, in each of the provinces of Canada except Quebec. The Offering may also be made in the United States or to or for the account or benefit of "U.S. persons" as defined by Regulation S under the U.S. Securities Act on a private placement basis to a limited number of institutional "accredited investors" (as defined in Rule 501(a)(1), (2), (3), (7), (8), (9), (12) or (13) of Regulation D under the U.S. Securities Act and to "qualified institutional buyers" pursuant to Rule 144A or in such other manner as to not require registration under the U.S. Securities Act or any applicable securities laws of any state of the United States, and in other jurisdictions as mutually agreed by the Company and Clarus.
Over-Allotment Option:	The Agent shall have an over-allotment option, exercisable in whole or in part, for a period of 30 days from and including the closing date of the Offering to purchase up to an additional 5,625,000 Common Shares exercisable in whole or in part, for additional gross proceeds of C\$6,750,000 on the same terms and conditions as the Offering (the "Over-Allotment Option").
Use of Proceeds:	The Company intends to use the net proceeds from the Offering to fund the continued advancement and de-risking of the Cordero Project and for working capital and general corporate purposes.
