Item 4. Summary of Material Changes

BCS Global Networks Inc. (the "Company") announced that its proposed name change and share consolidation had been fully approved and would take effect on September 2, 2003.

The Company also announced that it had retained Talisman Venture Partners Inc. to provide investor relations, public relations, business development and marketing services to the Company.

Item 5. Full Description of Material Changes

The Company has received final regulatory approval to a three old for one new share consolidation and name change to BCS Global Networks Inc. The share consolidation and name change will take effect at the opening September 2, 2003 and the Company will trade under its new symbol "BGN". Upon completion of the share consolidation, the Company will have 8,786,398 shares issued and outstanding of which 386,398 remain subject to escrow releases on a quarterly basis ending July 12, 2005.

Talisman Venture Partners Ltd. ("Talisman") has been retained by the Company to provide investor relations, public relations, business development and marketing services to the Company.

Talisman, a marketing and communications company based in Vancouver, BC, was founded by Nicholas Watters in 1999. Talisman has assisted several emerging companies in the start up stage, as well as numerous Fortune 500 companies. Importantly, Talisman has strong relationships in the Telecom sector in Canada and the USA and expects to leverage this experience to broaden awareness of the Company and increase revenue and partnering opportunities.

The Talisman agreement is effective September 1, 2003, for an initial period of three months, at \$5,000 CDN per month and a mutual option to renew the contract for an additional 9 months.
