Bologna, 14 April 2026

With regard to the ordinary and extraordinary shareholders' meeting of Unipol Assicurazioni S.p.A. called for 29 April next (the "Shareholders' Meeting" and "Unipol" or the "Company") to decide, *inter alia*, the composition of the Board of Directors, it is hereby announced that the proposal for the nomination of a new Board Member submitted- within the deadline indicated in the notice calling the Shareholders' Meeting - by shareholders who belong to the shareholders' agreement, significant in accordance with article 122 of legislative decree no. 58/1998, joining Unipol shareholders who own a total of 215,621,214 shares, equal to 30.053% of the share capital, in accordance with prevailing law, is available to the public at the registered office, on the authorised storage mechanism eMarket Storage (www.emarketstorage.it) and on the Company's website www.unipol.com (under the section *Governance/Shareholders' Meetings/Ordinary and Extraordinary Shareholders' Meeting - 29 April 2026*).

It also operates in the real estate, hotel (UNA Italian Hospitality), medical-healthcare (Santagostino) and viticultural (Tenute del Cerro) sectors. The ordinary shares of Unipol Assicurazioni S.p.A. have been listed on the Italian Stock Exchange since 1990, and are also on the FTSE MIB® and MIB® ESG indexes.
