MANAGEMENT DISCUSSION AND ANALYSIS
For the Period Ended January 31, 2023

The following Management's Discussion and Analysis ("MD&A"), prepared as at March 27, 2023, should be read in conjunction with the unaudited condensed interim financial statements of Superior Mining International Corporation (the "Company" or "Superior") for the period ended January 31, 2023 and the related notes thereto, which have been prepared in accordance with International Financial Reporting Standards ("IFRS").

Readers may also want to refer to the July 31, 2022 audited consolidated financial statements and the accompanying notes.

This MD&A contains "forward-looking statements" that are subject to risk factors set out in a cautionary note contained herein. All figures are stated in Canadian dollars unless otherwise indicated.

Company Overview

The Company is a Canadian company originally incorporated in the Yukon Territory, but now continued and registered as incorporated in British Columbia. It is listed on the TSX Venture Exchange under the symbol SUI. The Company was engaged in the acquisition and exploration of mineral properties in Canada. To date, the Company has not earned significant revenues and is considered to be in the exploration stage.

The Company is in the process of exploring its mineral properties and has not yet determined whether the properties contain reserves that are economically recoverable or not. The recoverability of the amounts shown for mineral properties and related deferred exploration costs are dependent upon the existence of economically recoverable reserves, the ability of the Company to obtain necessary financing to complete the development of those reserves and upon future profitable production.

In March 2020, the World Health Organization declared coronavirus COVID-19 a global pandemic. This contagious disease outbreak, which has continued to spread, and any related adverse public health developments, has adversely affected workforces, economies, and financial markets globally, potentially leading to an economic downturn. It is not possible for the Company to predict the duration or magnitude of the adverse results of the outbreak and its effects on the Company's business or ability to raise funds.

The Company's business financial condition and results of operations may be further negatively affected by economic and other consequences from Russia's military action against Ukraine and the sanctions imposed in response to that action in late February 2022. While the Company expects any direct impacts, of the pandemic and the war in the Ukraine, to the business to be limited, the indirect impacts on the economy and on the mining industry and other industries in general could negatively affect the business and may make it more difficult for it to raise equity or debt financing. There can be no assurance that the Company will not be impacted by adverse consequences that may be brought about on its business, results of operations, financial position and cash flows in the future.

Monexco Group Property

On November 30, 2021, the Company announced the acquisition of the Monexco Group Property located about 10km north of the town of Chibougamau, Northern Quebec region. The Property, extending for 30km on its longest axis, is comprised of 204 claims totalling more than 11,000 hectares.

During the year ended July 31, 2022, the Company abandoned the property before making any payments.

Vieux Comptoir Lithium Property

In December 2022, the Company entered into an option agreement to acquire a 100% interest in the Vieux Comptoir Lithium property located in Quebec. To execute the option, the Company is required to make the following payments:

- i) \$7,500 in cash upon execution of the option agreement (paid);
- ii) 7,000,000 common shares upon receipt of approval of the TSX Venture Exchange;
- iii) 3,500,000 common shares payable on the one year anniversary of the option agreement; and
- iv) 3,500,000 common shares payable on the 18 month anniversary of the option agreement.

In the event the Company acquires a 100% interest in the property, the Company will subject to a 3% NSR and the NSR may be reduced to 1.5% upon making a cash payment of \$3,000,000.

Results of Operations for the Six Months Ended January 31, 2023:

During the six months ended January 31, 2023, the Company had a comprehensive loss of \$78,141 (2022 – \$134,550). Significant fluctuations occurred in the following categories:

- a) Consulting of \$Nil (2022 – \$30,923) decreased due to no consulting fees incurred in the current period.
- b) Foreign exchange gain of \$155 (2022 – \$1,564) relates to the conversion of outstanding foreign currency accounts payables into the functional currency of the Canadian dollar.
- c) Management and director fees of \$Nil (2022 – \$55,901) decreased primarily due to no fees paid or accrued to directors during the current period.
- d) Marketing of \$50,174 (2022 – \$Nil) increased due to the timing of marketing fees incurred during the current period.
- e) Office & miscellaneous of \$2,091 (2022 – \$5,864) decreased primarily due to decreased activities during the current period.
- f) Flow through premium recovery of \$9,667 (2022 - \$Nil) due to exploration expenditures incurred against flow-through spending requirements in current period.

Results of Operations for the Three Months Ended January 31, 2023:

During the three months ended January 31, 2023, the Company had a comprehensive loss of \$60,244 (2022 – \$68,141). Significant fluctuations occurred in the following categories:

- a) Consulting of \$Nil (2022 – \$15,390) decreased due to no consulting fees incurred in the current period.
- b) Foreign exchange loss of \$386 (2022 – gain of \$949) relates to the conversion of outstanding foreign currency accounts payables into the functional currency of the Canadian dollar.
- c) Management and director fees of \$Nil (2022 – \$ 27,980) decreased primarily due to no fees paid or accrued to directors during the current period.
- d) Marketing of \$50,174 (2022 – \$Nil) increased due to the timing of marketing fees incurred during the current period.
- e) Office & miscellaneous of \$827 (2022 – \$2,328) decreased primarily due to decreased activities during the current period.
- f) Flow through premium recovery of \$9,667 (2022 - \$Nil) due to exploration expenditures incurred against flow-through spending requirements in current period.

Liquidity and Capital Resources

The Company's cash position as at January 31, 2023 was \$583,319 (July 31, 2022 – \$7,990).

Net cash used in operating activities for the period ended January 31, 2023 was \$56,511 compared to \$100,571 during the comparative period. The cash utilized by operating activities for the period consists primarily of the operating expenses and changes in non-cash working capital.

Net cash used in investing activities for the period ended January 31, 2023 was \$22,500 compared to \$Nil during the comparative period. The cash utilized by investing activities for the period consists primarily of exploration and evaluation asset.

Net cash provided by financing activities for the period ended January 31, 2023 was \$654,340 compared to net cash used in financing activities of \$3,078 during the comparative period. The cash provided by financing activities for the period consists primarily of advance from directors and proceeds from share issuance.

Other related party transactions

At January 31, 2023, the amount advanced from CFO was \$107,724 (July 31, 2022 – \$61,734).

The amounts due to related parties and the amount advanced from directors are unsecured, with no repayment terms, and without interest.

Capital Management

The Company's objective when managing capital is to safeguard the entity's ability to continue as a going concern. In the management of capital, the Company monitors its adjusted capital which comprises all components of equity (i.e. capital stock, reserves, and deficit).

The Company sets the amount of capital in proportion to risk. The Company manages the capital structure and makes adjustments to it in the light of changes in economic conditions and the risk characteristics of the underlying assets. In order to maintain or adjust the capital structure, the Company may issue common shares through private placements. The Company is not exposed to any externally imposed capital requirements. The Company's policy remains unchanged from the prior period.

Financial Instruments

The Company's financial instruments consist of cash, accounts payable and accrued liabilities, and advance from directors. Unless otherwise noted, it is management's opinion that the Company is not exposed to significant interest or credit risks arising from these financial instruments. The fair value of these financial instruments approximates their carrying value, unless otherwise noted.

The Company's risk exposures and the impact on the Company's financial instruments are summarized in Note 9 to the Company's financial statements.

Risks and Uncertainties

The Company may be exposed to risks of varying degrees of significance which could affect its ability to achieve its strategic objectives. The Company manages risks to minimize potential losses. The main objective of the Company's risk management process is to ensure that the risks are properly identified and that the capital base is adequate in relation to those risks. The additional risks to which the Company is exposed are described below.

The Company's operations and results are subject to a number of different risks at any given time. These factors, include, but are not limited to, disclosure regarding exploration, additional financing, project delay, price fluctuations and share price volatility, operating hazards, insurable risks and limitations of insurance, management, foreign country and regulatory requirements, currency fluctuations and environmental regulations risks.

The key determinants as to the Company's operational outcomes are as follows:

- a) the state of capital markets, which will affect the ability of the Company to finance further mineral property acquisitions and expand its contemplated exploration programs;
- b) the prevailing market prices for base metals and precious metals; and
- c) the ability of the Company to identify and successfully acquire additional properties in which the Company may acquire an interest whether by option, joint venture or otherwise, in addition to or as an alternative to the property.

Exploration and Mining Risks: Exploration for mineral resources involves a high degree of risk. Few properties that are explored are ultimately developed into producing mines. The cost of conducting programs may be substantial and the likelihood of success is difficult to assess. The Company has limited financial resources and, as pointed out above, has no current source of recurring income with which to cushion financial setbacks. In future there is no assurance that the Company will produce revenue, operate profitably or provide a return on investment. The Company seeks to counter this risk as far as possible by selecting exploration areas on the basis of their recognized geological potential to host economic deposits. The focus of the Company is on areas in which the geological setting is well understood by management.

Metal Price Risk: Metal prices have historically fluctuated widely and are affected by numerous factors beyond the Company's control, including international, economic and political trends, expectations for inflation, currency exchange fluctuations, interest rates, global or regional consumption patterns, speculative activities and worldwide production levels. The price of gold is affected by numerous factors beyond the control of the Company and can be extremely volatile. The price of this metal greatly affects the value of the Company.

Financial Markets: The Company is dependent on the equity markets as its sole source of operating working capital and the Company's capital resources are largely determined by the strength of the junior resource markets and by the status of the Company's projects in relation to these markets, and its ability to compete for the investor support of its projects.

Permits and Licenses: The Company's operations may require licenses and permits from various governmental authorities. There can be no assurance that the Company will be able to obtain all necessary licenses and permits that may be required to carry out exploration, development and mining operations at its projects.

Industry: The Company is engaged in the acquisition and exploration of resource properties, an inherently risky business, and there is no assurance that an economic mineral deposit will ever be discovered and subsequently put into production. Most exploration projects do not result in the discovery of commercially mineable deposits.

Capital Needs: The exploration of the Company's future properties will require additional financing. The only current source of future funds available to the Company is the sale of additional equity capital. There is no assurance that such funding will be available to the Company or that it will be obtained on terms favorable to the Company or will provide the Company with sufficient funds to meet its objectives, which may adversely affect the Company's business and financial position. Failure to obtain sufficient financing may result in delaying or indefinite postponement of exploration activities on the Company's future properties or even a loss of a property interest.

Critical Accounting Policies

Reference should be made to the Company's significant accounting policies contained in Note 3 of the Company's audited financial statements. These accounting policies can have a significant impact of the financial performance and financial position of the Company.

Going Concern

The financial statements are prepared in accordance with IFRS on a going concern basis, which presume the realization of assets and discharge of liabilities in the normal course of business for the foreseeable future. In assessing whether the going concern assumption is appropriate, management takes into account all available information about the future, which is at least, but not limited to, twelve months from the end of the reporting period. Management is aware, in making its assessment, of material uncertainties related to events or conditions that may cast significant doubt upon the entity's ability to continue as a going concern.

The Company does not generate sufficient cash flow from operations to adequately fund its future exploration activities and has relied principally upon issuance of securities and loans from related parties to fund its exploration and administrative expenditures. The Company may also seek to option out its properties in order to generate cash flows. These conditions raise substantial doubt regarding the Company's ability to continue as a going concern.

The Company will require additional capital to fund its future property acquisitions and exploration programs as well as for administrative purposes. If the management is unable to obtain new funding, the Company may be unable to continue its operations, and amounts realized for assets may be less than amounts reflected in these financial statements.

The financial statements do not include adjustments to amounts and classifications of assets and liabilities that might be necessary should the Company be unable to continue operations.
