Starfire Minerals Inc. - Option Agreement re Warren Property

Mr. Michael Caron reports:

The Company has signed a letter of agreement with three partners with regard to the optioning of the Warren Property consisting of 14 patented claims in Whitesides Township in the Porcupine Mining Division, Timmins area, Northern Ontario. The property is 50 km west of Timmins, Ontario and is quite accessible by vehicle.

The Company is obligated to make cash payments of \$48,000 and issue 200,000 common shares during the first three years. On reaching commercial production, the partners are to receive 3% NSR and the Company can buy back 1% for \$1 million.

The geology underlying the claims are archaean aged, mafic to ultramafic intrusive rocks of the Massey-Whitesides intrusive complex. The body is a differentiated anorthositic gabbro intrusive, and is expansive over several townships. Outokumpu Mines recently completed a feasibility study on their Montcalm Township nickel project, some 14 miles to the north west. This deposit is hosted by similar intrusive rocks. Mineralization on the Warren claims consists of discrete northerly trending sulfide zones. The sulfide mineralization as seen in drill core is net-textured pyrrhotite, pentlandite and chalcopyrite to 5% total sulfide. Highlight values include 2.5% Cu and Ni over 7.6 meters and 2.8% Cu and Ni over 8.2 meters from drilling and values up to 5.0% Cu, 2.5% Ni and .2% Co over a strike length of 600 meters on surface. Some 23 holes were drilled on the Warren showing leading to a resource estimate of 385,000 tons at 1% Cu and Ni combined and open in all directions.

The Warren deposit is marked well by electromagnetic EM survey, showing a distinct associated anomaly. Several such anomalies remain untested on the property. Historic EM surveys on the Warren patents have outlined a parallel western zone.
