EA Education Terminates Letter of Intent for Proposed Acquisition of a Private School

April 8, 2015 - EA Education Group Inc. (the “Company” or “EA”) (CSE: EA) announces that it has terminated the non-binding Letter of Intent (LOI) dated March 27, 2015 with respect to the acquisition of a private school (JK-G8) that is located in the Greater Toronto Area (the “Proposed Acquisition”).

The Company decided to terminate the LOI because the Proposed Acquisition did not meet the audit and due diligence terms of the LOI.
