These options vest equally over a period of 3 years and are exercisable on or before May 5, 2021 at an exercise price of \$1.44 CAD per common share.

The Company is regretfully announcing the resignation of Sébastien Goulet from the Board of Directors. "Sébastien has helped Omni-Lite in many ways as a member of the Board," stated David F. Grant, Chairman and CEO. "Sébastien has agreed to stay on as a consultant to the Company as Omni-Lite executes its 2016 growth strategy."
