TUIAG has purchased own shares in the course of the share buyback program announced under Art. 2(1) Delegated Regulation (EU) of the Commission No 2016/1052 of 10 August 2018 on 16 August 2018. The purchase of shares was performed via the Frankfurt Stock Exchange (XETRA trading) by a credit institution retained by TUIAG.

A total amount of 14,196 shares was purchased on 16 August 2018. The volume-weighted average price of all shares purchased excluding transaction costs was EUR 16.56. The highest price paid was EUR 16.615; the lowest price paid was EUR 16.48 (in each case not including any transaction costs).

TUIAG's share buyback program has now been completed. The total amount of shares purchased by TUIAG in the course of the program since 13 August 2018 is 59,196. TUIAG thus holds 59,196 shares as treasury shares. The total number of TUIAG shares in issue less the total number of treasury shares is 587,327,704. The treasury shares will now be transferred to employees of TUI Group participating in the employee share participation program 'oneShare'.
