Dotcom 2000 Inc. ("Dotcom") (CDNX-YDC) announced today that it has completed the second tranche of its previously announced private placement financing to raise gross proceeds of \$750,000 in addition to the proceeds of \$675,000 raised by virtue of the first tranche. Further tranches are expected to close prior to March 26, 2001, such that the aggregate gross proceeds raised are approximately \$1,800,000. Full details of the private placement are set out in a press release dated February 15, 2001.

William Robinson, the President of Dotcom 2000 Inc., stated "This transaction strengthens our current working capital position and provides us with additional capital to continue the development of our proprietary audio/video ("A/V") streaming software technologies. We anticipate releasing Version 2.1 of our existing A/V streaming software, in the next 60 days. This new version of our A/V streaming software will provide live two-way audio and one-way video communications over the Internet. Our browser based A/V streaming software requires no downloads and is a substantial improvement over A/V streaming software available from our competitors. The market opportunities for this product include the online entertainment industry, business to business and business to consumer Internet communications".

Dotcom is an Internet software development and marketing company that specializes in audio/video communications software, online entertainment services, e-commerce applications, and database management. Dotcom owns 100% of Globalvest Partners Inc., a St. Kitts company, and 100% of LPN Productions Inc., an Ontario corporation. Globalvest holds a license to conduct Internet gaming in St. Kitts and operates an Internet casino at web address www.crowncitycasino.com. LPN Productions Inc. is an Internet broadcast and production facility that operates the web site www.livepsychicnetwork.com which provides live interactive video and audio psychic readings and related services on the Internet.
