STONEPOINT ANNOUNCES CONSULTING AGREEMENTS

July 23, 2009, Vancouver, British Columbia - StonePoint Global Brands Inc. ("StonePoint" or the "Corporation") (TSX-V: SPG) announces that it has entered into consulting agreements with three consultants pursuant to which the consultants will provide to StonePoint consulting services related to the hospitality industry.

Each consulting agreement provides that the consultant will render consulting services to StonePoint in consideration for monthly compensation and, upon completion of certain initial consulting services, warrants to purchase 400,000 Class A voting common shares in the capital of the Corporation (the "Common Shares") for a period of three years from the date of issuance, subject to regulatory approval. The exercise price of the proposed warrants shall be equal to thirty percent (30%) above the average closing price of the Corporation's Common Shares over the twenty trading days preceding the completion of certain initial consulting services. The warrants will be issued pursuant to statutory exemptions under applicable securities laws and resale restrictions will apply to the warrants in accordance with applicable laws. Each consulting agreement has a term of three years.

In addition, the Corporation will provide each consultant with commissions on the revenue collected by the Corporation as a result of product sales generated from the consulting services.
