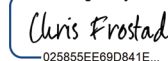

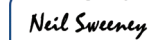

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Minden Gross LLP (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
