(“**Cellularline**” o “**Emittente**”) – società quotata su Euronext STAR Milan, mercato organizzato e gestito da Borsa Italiana S.p.A. – comunica di aver acquistato nel periodo compreso dal 15 settembre 2025 al 19 settembre 2025 n. 27.607 azioni ordinarie proprie (ISIN: IT0005244618), al prezzo medio ponderato di Euro 2,92533 per un controvalore complessivo di Euro 80.759,61.

Tali operazioni sono state realizzate nell’ambito dell’autorizzazione all’acquisto di azioni proprie deliberata dall’Assemblea dell’Emittente del 17 aprile 2025.

Reggio Emilia, 22 September 2025 – Cellularline S.p.A. (“**Cellularline**” or “**Issuer**”) – listed on Euronext STAR Milan, market organised and managed by Borsa Italiana S.p.A. – announces that it has purchased in the period between 15 September 2025 and 19 September 2025 n. 27,607 ordinary treasury shares (ISIN: IT0005244618) at the average weighted price of Euro 2.92533 for a total value of Euro 80,759.61.

These transactions were carried out as part of the authorisation to purchase treasury shares resolved by the Shareholders’ Meeting of the Issuer on 17 April 2025.

A summary is provided below of the purchases made, in the period indicated, of Cellularline ordinary shares on a daily basis and in detailed form:
